Agreement for Registration of Country Level Domain on Behalf of Customer

_____ (CUSTOMER) a company registered in _____
(country), having its principal operations at _____

hereby authorizes Webvisions Pte Ltd, and its subsidiaries (WVS) to register the following country level domain : _____ .com.my on its behalf.

CUSTOMER further agrees and will adhere to the following terms and conditions:

a) **CUSTOMER** will pay **WVS** a year fee of two hundred and fifty Singapore dollars (S\$250) for registering the following domain on its behalf. This fee excludes the yearly Domain Registration fees as listed at <http://register.webvisions.com>.

b) While **WVS** will be registered as the domain Owner on behalf of the **CUSTOMER**, the **CUSTOMER** undertakes to fully indemnify **WVS** in respect of **ANY** liability to a third party arising out of the registration and use of the above domain name.

Should the **CUSTOMER** at any time request that **WVS** assist in transferring Ownership of the domain name from **WVS** to the **CUSTOMER** or any other party, the **CUSTOMER** agrees to bear any fees or cost arising from the transfer.

c) With the exclusion of death or bodily injury directly caused by the fault or proven negligence of **WVS**, **WVS'** liability to the **CUSTOMER** for claims under and in connection with this **Agreement** irrespective of the form of action, whether for liability in contract, tort or otherwise shall be limited to the sum of the fees paid by the **CUSTOMER** to **WVS** under this **Agreement**.

d) Under no circumstances, unless specifically made within the terms of this **Agreement**, shall **WVS**, its officers, agents or anyone else involved in creating, recreating, producing or distributing **WVS** service be liable whether in contract, tort (including negligence or

breach of statutory duty) or otherwise for any direct, indirect, incidental, special or consequential loss or damages (including loss of revenue or profits) that result from the use of or inability to use of **WVS** service or the domain itself; nor shall liability be accepted for that which results from any mistakes, omissions, interruptions, deletion or loss of files, errors, defects, deficiencies, deterioration in quality, incompatibility, unsuitability, delays in operation, or transmission or any failure of performance, whether or not limited to acts of God, communication failure, power failure, theft, destruction, deletion, corruption or unauthorized access to **WVS** records, equipment, programs or services. The limitation of liability provided herein reflects the allocation of risk and material inducement for **WVS** to enter into this **Agreement**. With the exception of non-payment, neither party may bring any action, regardless of form, arising out of this **Agreement**, more than one (1) year after the cause of action.

e) Registration of a country level domain excludes the yearly Domain Registration fees. If **CUSTOMER** fails to pay the yearly domain registration fees, **WVS** may terminate the domain name registration on **CUSTOMER** behalf. **CUSTOMER** will be liable for any domain registration fees payable prior to the termination by **WVS**.

f) **CUSTOMER** agrees to adhere to all agreements and covenants as stipulated by MYNIC (available at www.mynic.net) with regard to the registration of a country level domain.
